# Introduction

This certification exam is the starting point of your HCL Digital Experience certification journey. This certification is to validate your knowledge on basic capabilities of HCL DX on v9.5+.

The HCLSoftware Certified Digital Experience Professional 9.5+ must demonstrate basic skills associated with building sites using the HCL DX product playing the role of different personas of business user, developer, and administrator.

# Requirements

There are no pre-certification requirements to attempt this HCLSoftware Certified Digital Experience 9.5+ Professional certification.

#### **Exam Format**

- Single choice: Has one correct response and three incorrect responses
- Multiple choice: Has two or more correct responses out of four or more response options
- Number of questions: 60
- Total score: 80Passing score: 56
- Passing Percentage: 70%
- Time duration for answering the 60 questions: 80 minutes.
- Total exam time duration: 90 minutes.
- Unanswered questions are scored as incorrect; there is no negative marking for incorrect answers.

#### Exam Results

The HCLSoftware Certified Professional - Digital Experience 9.5+ (HCL-DX-PRO-95) certification exam is a pass or fail exam. The exam is scored against a minimum standard established by HCLSoftware subject matter experts who follow certification industry best practices and guidelines.

The exam is scored based on a Sum of Scores which is then converted into a percentage to determine pass or fail. The sum of scores is achieved by weight assigned to each individual question based on level of complexity. The minimum score required to pass the exam is 56 out of a total of 80 points, which is 70%.

This exam guide includes competency areas and weightings for the exam as seen below. This exam covers content specifically for HCL DX v9.5+.
