HCLSoftware Certified Administrator – BigFix Compliance 10 Certification Exam Guide

Introduction

This *entry level* exam certifies that the successful candidate is familiar with HCL BigFix Compliance v2.x installed on HCL BigFix Platform 10.x. The successful candidate must demonstrate a basic knowledge of HCL BigFix Compliance functionality and security controls. They must know how to enable and manage the compliance components, and perform the required tasks including deployment, troubleshooting, reporting, monitoring, and administration of the environment.

The administrator is self-sufficient and is able to perform most of the tasks involved in this role with a limited amount of assistance from peers and vendor support services. The administrator efficiently uses product documentation.

- BigFix Console and WebUI
- Basic knowledge of operating systems
- Intermediate knowledge of networking
- Malware and Anti-Virus (AV) products
- Basic knowledge of cybersecurity
- Basic knowledge of Directory Servers
- Troubleshooting Procedures

Exam Format

- Multiple choice one correct response out of four choices
- Multiple Response two or more correct responses out of five or more choices
- Number of questions: 50
- Passing score: 76% (38/50)
- Exam duration: 75 minutes

Unanswered questions are scored as incorrect; there is no penalty for guessing.

Exam Results

The exam is scored using the Angoff method which is the lowest pass/fail cutoff score that a minimally qualified candidate is likely to achieve on the exam. This score was calculated by using a panel of subject matter experts who reviewed each question and performed an assessment of the level of difficulty of each question. This assessment is a prediction of the number of minimally qualified candidates that will answer the question correctly

Based on this review, the minimum score required to pass the exam is 38 out of a possible of 50.
